#### Shareholder Update - Delisting and New Issuer Sponsored Holding Statements

Dear Shareholder.

The Directors of BioDiem Ltd ("BDM") wish to advise you that the Company has now successfully delisted from the Australian Securities Exchange (ASX) effective 15 November 2013. As a shareholder, this means that you now hold shares/options in an unlisted public company rather than an ASX-listed public company.

#### **New Holding Statements**

As part of the de-listing process you will receive correspondence from the share registry with your new holding statements. These new Issuer Sponsored Holding Statements replace the CHESS holding statements which were in effect at the time of the delisting on 15 November 2013.

The Company has previously announced the reasons for de-listing the company. These were outlined in the 6 Sep 2013 Notice of Meeting and Explanatory Memorandum to the 2013 AGM. Shareholders approved the resolution to de-list at the AGM held on 8 October 2013. Our vaccine and antimicrobial programs are continuing and we will keep shareholders informed of progress through announcements made on our website and through direct emailing.
