COMPLETION OF NON-RENOUNCEABLE ENTITLEMENT OFFER AND ISSUE OF ENTITLEMENT AND SHORTFALL SHARES

BioDiem Limited ("BioDiem" or "the Company") advises that it has now completed the issue and allotment of entitlement and shortfall shares under the shortfall facility of its recent Non-Renounceable Entitlement Offer.

BioDiem confirms that it has raised a total of \$815,414 under the Entitlement Offer. A breakdown of the number of shares issued and funds raised under the respective components of the Entitlement Offer (the entitlement component and shortfall facility component) is as follows:

Effect of Rights Issue on Capital Structure

The Company confirms that following allotment of the entitlement and shortfall shares under the Entitlement Offer, BioDiem has 163,082,800 fully paid ordinary shares on issue. A current statement setting out the names of the 20 largest holders of fully paid ordinary shares and percentage held by each is attached. A table showing the Company's current capital structure is set out below.

Scale Back on Oversubscription of Additional Shares

As previously announced on 23 April 2014, the Company advised that it received applications for shares in excess of the number of shares available and accordingly the applications for additional shares have been scaled back.

Shortfall shares were allocated in proportion to the number of shares held by the shortfall applicant at the Record Date relative to the shares held by all shortfall applicants at the Record Date. This applied except where shortfall applicants applied for shortfall shares which would only have increased their holding to fewer than 10,000 shares. In those cases the shortfall applications were not accepted.

No allocation was made to the extent that the allocation would result in the holder obtaining a relevant interest of greater than 20% of the post offer total fully paid ordinary shares in the Company.

The scale back of shortfall applications did not apply to or affect valid acceptances of entitlements, with all shareholders who accepted their full entitlement being issued 1 share for every 10 shares held at the Record Date.

Confirmation of the number of shares issued will be sent to applicants. If not all shortfall shares applied for were issued, the relevant portion of the application funds received will be refunded.
