COMPLETION OF NON-RENOUNCEABLE PRO-RATA ENTITLEMENT OFFER AND ISSUE OF ENTITLEMENT AND SHORTFALL CONVERTIBLE PREFERENCE SHARES

BioDiem Limited ("BioDiem" or "the Company") advises that it has now completed the issue and allotment of entitlement and shortfall convertible preference shares under the shortfall facility of its recent Non-Renounceable pro-rata Entitlement Offer.

As notified previously to shareholders, two of BioDiem's largest shareholders contributed \$200,000 through an unsecured loan prior to the opening of this entitlement offer. Following conclusion of the successful capital raising under the Prospectus (i.e. subscription funds of \$800,000 or more) that loan was to convert to Convertible Preference Shares at the same price and with the same terms and conditions as those offered under the Prospectus. BioDiem confirms that it has raised a total of \$948,940.24 under the Entitlement Offer. A breakdown of the number of Convertible Preference Shares issued and funds raised under the respective components of the Entitlement Offer (the entitlement component and shortfall facility component) is as follows:

Effect of Rights Issue on Capital Structure
